

# Legacy Golf Club

## 2019 Corporate Season Pass

**The Legacy** is an upscale 18-hole championship course designed by Arthur Hills. The course is built on 207 acres on US-223, two miles west of US-23. The Legacy is just minutes from Toledo, Ohio. It has 5 beautiful lakes, including a par 3 with an island green. Five sets of tees allow the golfer to choose the degree of challenge for the day. Fairways, tees, and greens are all bent grass. The electric golf carts provide for a quiet and pleasurable round. Our range and putting green offer excellent practice opportunities.

The **Legacy Golf Club** has been nominated by **Golf Digest** as one of the best new “affordable” courses in the U.S. They have also rated the **Legacy 4 1/2 stars** and designated one of the ‘**Top 200 Places to Play**’ in 2004 out of over 6,900 courses in the country. **Legacy Golf Club** offers country club conditions made available to the public.

Rounds can be used weekdays or weekends, 9 or 18 holes per visit, and include a cart. There are **no dues or minimums** as in many course memberships and passes.

### THE LEGACY CORPORATE PASS INCLUDES:

- **70 Rounds of golf with cart** if payment is received before January 31st
  - 65 Rounds after January 31.
  - Golf rounds may be used for open play on weekdays, weekends, & holidays
  - Corporate rounds cannot be used for outing rounds. Limited exceptions can be negotiated with the general manager.
- **All rounds are per calendar year**
  - Rounds do not carry over to the next year unless play pass is renewed for the upcoming year.
- Corporate Pass includes unlimited range balls
- Corporate Purchaser may designate up to four pass holders for signing-in players for play.
- Designated play pass holders receive discount on USGA handicap service and 10% discount on regularly priced pro shop merchandise
- Corporate Pass purchaser can activate charge account privileges that are invoiced monthly.
- Corporate Pass holders may call up to **21 days** in advance for preferred tee times.
